Catalog Description

Introduction to concepts and theories applicable to a national economy.

Prerequisites: Sophomore standing. G.E. Course meets Multicultural graduation requirement.

Additional Notes

Economics is the study of human action in a social market context. That is, we try to understand how people make decisions and take action to produce, trade, and consume goods and services as we try to improve our material lives. We can study economics on a variety of levels, from individuals and families to small and large firms to industry sectors and whole economies.

This is a course in macroeconomics, a large-scale look at how a national economy functions. Even though only individuals make decisions and take action, we can still learn a lot by studying what happens when large numbers of individuals act, responding to one another's actions under the same set of conditions.

3. Describe the role of government in the U.S. economy; analyze the functions of government; explain the concepts of fiscal and monetary policy and how these tools of government policy are used.
4. Describe the major components of GDP, including consumption, investment, government, and net exports; explain and analyze the factors that impact each of these components of aggregate spending.
5. Describe and explain the banking system, including the role of commercial banks and the Federal Reserve and describe the way in which money is created in our economy.

Assignment Overview

Online Learning Activity

This course uses an online learning application called MyEconLab, which is designed to accompany your textbook. You must have access to MyEconLab in order to complete the online graded assignments for this course. There are eight MyEconLab modules, one for each week. Each module includes between 17 and 30 questions to complete and are worth either 18 or 19 points. You are encouraged to use the text (paying particular attention to "key graphs") and the resources in MyEconLab accompanying the text.

There is no time limit and problems for each week may be accessed multiple times before the deadline for each module. You have two attempts at every homework problem. The advantage of having two attempts at each question comes with a cost. Once an answer is submitted, those answers are unchangeable. If you erroneously check a wrong selection, or superimpose or misalign your answer electronically from what you intended, the answer is deemed to be your final answer.

Upon submission, results are automatically scored and immediately available for viewing. Detailed results, including correct and incorrect answers, are made available for viewing only after the deadline for submission has passed. You are responsible for observing the rules regarding academic honesty. Make-up MyEconLab assignments are allowed only for exceptional circumstances.

Assignments

Each week we will have a quiz and some activities during class. The activities will be your opportunity to contribute to class learning. Your participation is important for both your learning and your classmates'.

The Dropbox assignment draws on the text, class discussion, and sometimes outside sources. It is designed to be completed after the class meeting, so that your work will be based on the entire week's lessons and learning. These assignments are 50 points each, graded on the basis of percent of completeness, correct concept analysis, spelling, and grammar.

These assignments will be your own work, completely. Any statements in your answer that are drawn from other sources must

be properly referenced. The preferred format is APA, 6th edition. If you neglect to reference properly, that is plagiarism. If I discover plagiarism you will receive a zero on that assignment. If there is a second incident, you will receive an F for the course and I will report the reason for the grade to the Academic Affairs office.

Each assignment will be due as one complete document, submitted to the appropriate box no later than midnight Sunday. Please submit your work as a Word file (.doc or .docx).

Examinations

There will be an on-line quiz each week. You will have 24 hours after class ends each week to complete the quiz.

The midterm exam will be during week four and will cover material from the first four class meetings. The final exam will be during week eight and will cover material from the entire course, but will emphasize material from weeks five through eight. You will take both exams online in the days after class. This will give you the opportunity to digest the material from the last class before taking the exam. Each exam is worth 200 points.
